# INNOVATION IN OPHTHALMOLOGY—Teaching Students the YouTube way

On May 4th 2012, retinal specialist Dr. Sanjay Sharma from Hotel Dieu Hospital, Kingston ON received an achievement award from the Ontario Medical Association (OMA) for his success in tapping the power of technology to teach medical students how to diagnose and treat eye conditions. Research evaluating its effectiveness was published this month in the *Canadian Journal of Ophthalmology* demonstrating that medical students learning how to diagnose and treat acute visual loss through watching video content, performed better than students who learned the material through traditional methods, and in a quarter of the time! Committed to perpetuating the healing mission of Jesus

#### FOR-PROFIT CATHOLIC HEALTHCARE:

Brighton, Mass based **Caritas Christi Health Care**, now named Steward Health Care System, became a for-profit company after being purchased by a private investment firm. The system's six hospitals continue to be recognized as Catholic facilities by Boston's Cardinal.

Ascension Health, the largest Catholic and the largest not-for profit healthcare system in the United States has partnered with an equity firm to create Ascension Health Care Network, "an acquisitive, equity-based, for-profit Catholic health care system, which will grow through acquisition of struggling non-profit Catholic health care facilities and networks, offering them much-needed capital and the ability to retain their Catholic identity and sponsorship while converting them to for-profit entities."

Catholic Healthcare West has reorganized its governance structure and changed its name to Dignity Health. Under the new governance model the San Francisco-based company is no longer an official ministry of the Catholic Church. The company, which operates 40 hospitals in three states, announced its intent to build a national health care system rooted in the Catholic tradition with both Catholic and other-than-Catholic components and partnerships.

These changes from not-for profit to for-profit hospitals, raise many questions and issues surrounding mission and community benefit, ethical directives and their not for-profit tax exempt status.

**CHA US** is trying to determine how to deal with these entities as part of their ministry community going forward, as one of the criteria for membership is **not for profit** status. CHA US has established a task force to look at this issue, and to decide whether or not to change their bylaws in order to allow these for-profit entities to remain members.
